Sparton's core asset is a minority interest (9.975%) in a clean tech, vanadium flow battery producer VRB Energy Inc.

The majority shareholder is Ivanhoe Electric Inc., part of the Robert Friedland managed Ivanhoe Group of companies. VRB Energy is the world's leader in integrating long life, grid scale storage batteries with wind or solar sources of electricity.

- These batteries are safer (cannot catch fire), longer lasting and are cost competitive with lithium units. They are fully
  recyclable. They have been installed in multi megawatt sizes for renewable solar and wind integration.
   VRB Energy has the only UL1973 safety certificate for its units in the Industry.
- The company received the CSA safety certification for its Generation 3 Vanadium Battery Stack. Unique in the industry.
   It is also certified for ultra cold weather (-40°C). and ultra high-altitude operations.
- Recently, the company has made major announcements which will result in a phase of rapid expansion in China and the U.S.A. with USD \$55 million in investments. VRB USA development is now underway with an initial US\$20M investment






# PRODUCT PERFORMANCE



#### West of Kirkland Lake, Ontario


- Sir Harry Oakes Leases + Additional (36) Mining Claims
- Continued Exploration on former
   Sir Harry Oakes owned Gold Project
   with limited exploration since 1936
- Claims are only 3 km north of Alamos Gold's operating mine which produces 200,000 oz. of gold annually
- Sparton did a modest drilling program in one area near the old shaft with some positive but mixed results
- Completed detailed induced polarization and magnetic surveys and identified at least 4 new targets on the claim group that have never been evaluated in the past. These will be tested by trenching and possibly drilling later in 2025.



### Pense Polymetallic Property

Near Englehart, Ontario


- 91 claims (+3700 hectares)
   100% Sparton owned
- Near Quebec provincial border,
   25 km east of Englehart, Ontario
- At least 9 priority areas located in recent airborne electromagnetic and magnetic survey. Past work showed good Copper, Zinc, Gold, Silver, Nickel, and Cobalt values and not followed up, New targets have never been tested
- A high resolution electromagnetic and magnetic survey completed in 2024.
   Phase 1 drilling program completed.
   Historic and current positive drill results.
- Historic positive drill results confirmed in new drilling for Copper Nickel Zinc And Gold.
- Highlights 0.14% Cu /27.7m, 0.12%
   Ni/7.4m, 1.8% Zn/ 19m, 0.15% Ni/ 12m, 0.12%Ni/7.4m
- 0.81g/t Au/8.2m, 11.5g/t Au/30cm (Historic), 1.8g/t Au/9m (Historic)
- Up to 8 untested targets remain



### Bruell Gold Royalty Property

East of Val d'Or, Quebec

- The Bruell project in Quebec is now 100% Eldorado Gold Corp. which operates the Lamaque/ Sigma gold mine complex east of Val D'Or, Quebec – producing over 135,000 ounces gold per year - and controls a large property package (including Bruell) east of the Lamaque operations.
- Eldorado completed over 12,000 meters of drilling at Bruell since 2019 and reported some positive results.
   Sparton has sold its 25% interest to Eldorado and retains an NSR Royalty.



- Eldorado positive drill results included a new discovery in the Penguin zone
- In late November 2024, Eldorado exercised its purchase option to buy Sparton's 25% interest in Bruell and will pay Sparton \$275,000 cash plus a 2% NSR production royalty, with a buyback of 1% of the royalty for CAD\$2 million.


## PENSE CRITICAL METALS PROJECT

### Highlights

- Critical metals project in a mostly unexplored area of Ontario and Quebec, 100% Sparton
- Known critical metals mineralization on claims with no significant exploration for nearly 25 years
- Mineralization similar to world class Outokumpu copper-zinc-nickel deposits in Finland




- Recent detailed airborne electromagnetic survey has located 9 distinct bedrock targets
- . Limited historic drill testing of only two targets with positive Critical Metals assay results - no follow up until Sparton work
- Recent ground surveys have confirmed 9 targets with strong **EM and Mag signatures**
- Completed initial drilling in October 2024 with encouraging results for copper, nickel, zinc, and gold
- Exploration project subsidies available in Ontario and Quebec







#### EM TARGET BLOCK MODEL
